The one-day program includes a minimal review and administration of the written exam. Passing the written exam will certify you as a Concrete Flatwork Associate.

To certify as a Concrete Flatwork Finisher or Advanced Finisher further criteria must be met. If you'd like to submit for these additional titles please complete the forms attached to collect this data. These must be turned in the day of the test.

There will be no actual performance exam for Finisher certification

The agenda for the day will be:

- 10:00 a.m. – check in and review exam administration and protocol
- 10:15 a.m. – written exam will be administered
- 12:15 p.m. – upon completion of written exam, those wishing to certify as a Technician and Finisher will need to turn in the proper forms.

A complete review of the test procedures will not be provided. This is not a training class and technicians are expected to be familiar with testing equipment and competent in conducting flatwork testing methods.

Applicants are required to bring #2 pencils, proof of identification, and a non-programmable calculator. Programmable calculators or cell phones will not be allowed in the written exam.

Registration is limited to the first 15 applicants. It is very important to register as soon as possible so you have adequate time to receive and review study materials prior to the examination. The exam is based on information contained in ACI CP10(10), or newer. ALL RECERTIFICATIONS require successful completion of the written exam.

Your test will not be administered without payment. **To HOLD your place in the class and receive your study material early you should e-mail registration forms to icapaidaho@gmail.com.** To **GUARANTEE** your place in class, **payment MUST be received by July 1, 2020.** **SEE REGISTRATION FOR CANCELING – SUBSTITUING POLICY.**
